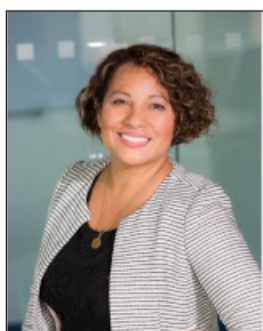

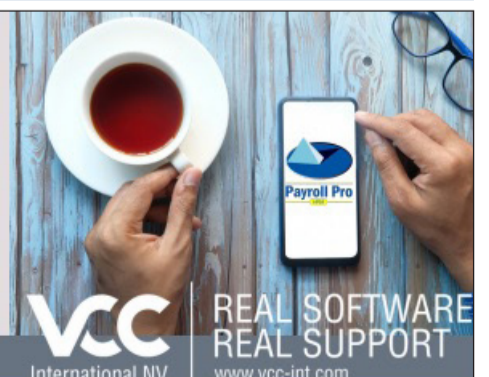

Segun van Huffelen, gobierno Hulanda bou di ningun circunstancia kier pa Sint Maarten resulta esun mas perhudica pa e posicion tuma pa gobierno di Pisas siman pasa relaciona cu e e fondo di pensioen di Ennia.



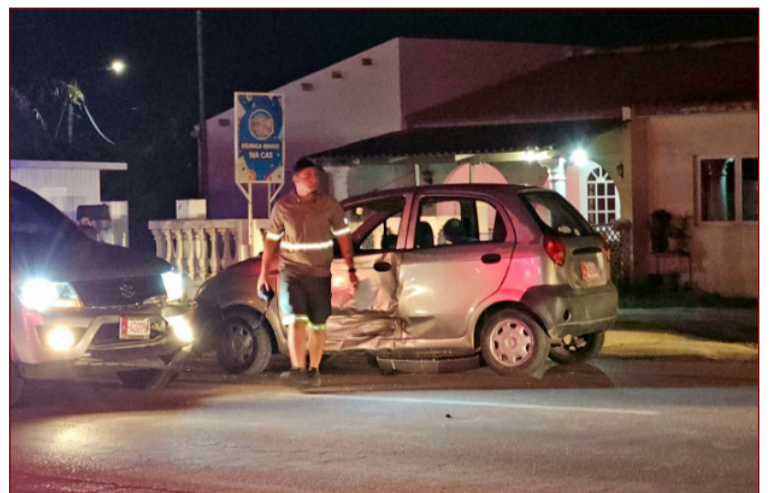

 1 pizca de pimienta negra recién molida
 8 onzas parmesano rallado
 50 onzas Salsa marinara
 8 onzas Queso Mozzarella Rallado
 2 rebanadas de pan francés crujiente, para servir

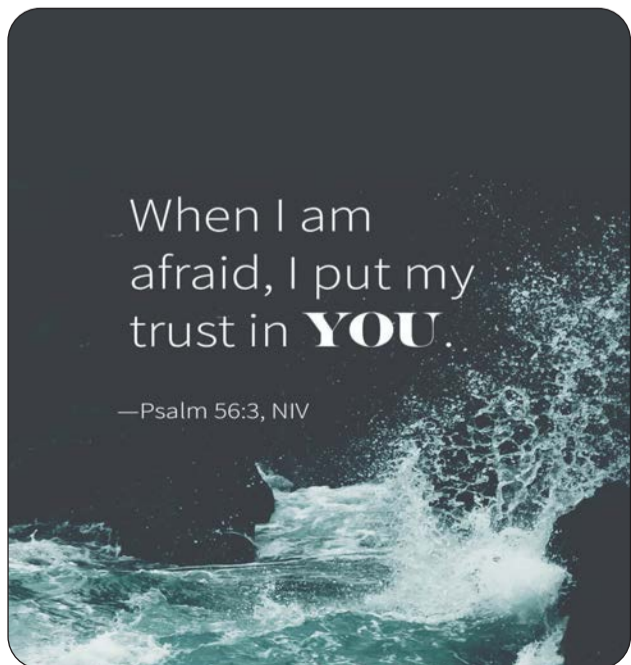

HOH with update regarding the situation at our Gynecology clinic



AFTER a few months of hard work from the team at HOH, the Board of Directors is glad to inform the community of the latest positive developments about staffing at the Gynecology clinic. Before that, we would like to thank you once again for your patience, and above all we would like to thank the team of our gynecology clinic for their dedication and efforts to do their utmost best in difficult times.

A few months ago, the Horacio Oduber Hospital (HOH) emitted information regarding longer waiting times and the change of doctors at our Gynecology clinic. We informed the public about the current situation with the request for comprehension and patience from our patients, the public and employees.

Reason behind this was the current high pressure on the number of gynecologists. Some decided due to personal reasons to change their career. At the same time, we had manpower discussions with AZV about the number of gynecologists, which made the situation challenging. We were reduced from 7 to 5 gynecologists. We are happy we recently agreed with AZV to have 6 gynecologists contracted at the hospital, and maybe in the near future go back to 7 gynecologists.

Vacancy and substitution

As is known for some time now, there is a worldwide shortage of medical staff and specialists. Our recruitment department has been working very hard finding replacements that meets our qualifications. We are happy to inform that in the month of November, the team at our gynecology clinic will be welcoming Dr. Femke Siemonsma and in January of 2024 we say bon bini to Dr. Sofie Hamers and Dr. Dominique Bos.

Also Dr. Sietske Althuisius, who just left for retirement, will come back to strengthen the team for an additional year.

In the meantime, Dr. Daphne Moreta (president of the group) together with Dr. Alejandro Garcia ensure the continuity of the group. In addition, Dr. Babet Latour will be giving care until the end of November, before taking on a new challenge in The Netherlands. The open vacancies are continuously filled to 6 FTE temporarily with substitute specialists: Dr. Marcela Realpe, Dr. Frank Ho-Kang-You, Dr. Gunilla Kleiverda and Dr. Soerin Mahadew.

Appreciation

We are doing our utmost to guarantee care for our patients and to bring balance back to our gynecology group. Not only to fulfill the vision of our organization: 'accessible healthcare for everyone without compromising on quality', but also to provide a pleasant place to work for our employees.

The coming months, we will work to reduce waiting times for an appointment to an acceptable number of days. A certain waiting time will always be there and compared to other countries, waiting times in Aruba are in general quite acceptable. However, we understand of course that when you are ill, or having problems, you want to be seen as quickly as possible. Important to mention is that emergencies always are and have been attended to immediately.

Once again, the Board of Directors is grateful and want to express their gratitude to all employees and patients for their patience and ask kindly to continue to have mutual respect for the current circumstances.

Casita Geel's Doors to Reopen to the Public Once Again

DURING a press conference, the director of the Aruba Monument Foundation (SMFA), Anne Witsenburg, announced that starting from October 1, 2023, the historic monument known as Casita Geel would have a new lease on life.

Over the past month, SMFA has been working intensively to adapt the building for its new purpose. Now, this early 20th-century country house will be transformed into a place of entertainment for both locals and tourists under the name "Moonshine Daiquiri Co."

Tonya Shenkin, co-owner of Moonshine Daiquiri Co., shared her journey to Aruba, which began 23 years ago when she first visited the island. Now, she not only has a home in Aruba but also her own business. With extensive experience in the nightclub industry, managing four clubs in the New York/New Jersey area, Tonya's passion for hospitality drove her to start her own venture.

In 2020, during the Covid pandemic, she decided to follow her dreams: building her own home and starting her own business in Aruba. Now, she's ready to share her love for the island with locals and visitors from around the world.

Moonshine Daiquiri Co. is a concept that Tonya developed after years of travel, blending her own preferences with what the island has to offer. She was aware of the area she wanted her establishment to be located in, but she never imagined she would occupy a historic monument like Weststraat 15. For Tonya, this was the cherry on top because it allows her to contribute to preserving a part of Aruba's history while bringing new life to this landmark.

Moonshine Daiquiri Co. will be a family-friendly space, welcoming everyone. Cruise lines will sell tickets to Moonshine Daiquiri Co. as part of their excursions, including a tour of Weststraat 15 and a 2-hour "paint and sip class." Tours will be available every 2 hours from 10 am to 6 pm. The venue will also be open to the general public, and there will be evening activities, private events, and fundraisers to support local charitable organizations.

In an effort to give back to the community, there will also be opportunities for locals to sell their Aruba-made products. Soon, a job fair will be held to recruit instructors for painting lessons, bartenders, hosts, waiters, musicians, and more. The mission of Moonshine Daiquiri Co. is to create and share beautiful memories and the same love and appreciation Tonya has for Aruba.

About Casita Geel:

Casita Geel is a country house built in 1908, located at the corner of Caya Betico Croes and Waterweg, adjacent to the



current Aruba Bank building. The central part of the house was likely constructed in 1860 by a Frenchman and, in 1908, it was purchased by Mr. Richard Johan Eman van der Biest, who resided there with Catharina van der Biest-Oduber. The marriage produced six children, all of whom were raised in this house. One of their daughters, Frederica van der Biest-Eman, married John Gerard Eman, the founder of Aruba's first financial institution, Aruba Bank. Since 1999, the house has remained uninhabited and unused.

In 2000, with the goal of preserving the house for future generations and preventing it from being lost, the decision was made to relocate Casita Geel to a new location on Weststraat. To allocate the monument, a suitable piece of land in Oranjestad was sought after, as this area was where these types of country houses were typically found. Another crucial aspect was to find a location that would allow the house to be placed in a similar position to its original location, maintaining a historical context. This was achieved when the land was transferred to the Aruba Monument Foundation. This is the first time in Aruba's history that a monument has been completely relocated. After serving as a museum, an office, and a restaurant, Casita Geel will now be the new home of Moonshine Daiquiri and Co.

The SMFA team wishes Tonya and Jerome every success, and together, they will continue to preserve the past for the future!

Gazprom Neft Announces Historic Shift:

Ends Reliance on U.S. Dollar for Oil Trade



IN a monumental move that could have far-reaching implications for global trade dynamics, Gazprom Neft, Russia's third-largest oil exporter, has declared its intention to break away from the traditional reliance on the U.S. dollar for cross-border transactions. The company has assured that it can handle various foreign currencies from around the world, signaling its commitment to diversifying its transactional landscape.

At present, the oil exporter has not expanded its payment systems to include other local currencies, such as the Indian rupee. It primarily conducts transactions in Chinese yuan and Russian rubles. However, if other major oil firms choose to follow Gazprom Neft's path, the vulnerability of the U.S. dollar as the dominant global currency for trade could be further underscored.

Oil Prices Surge, Stocks and Currencies Fall

THE world witnessed a significant impact on global markets as the conflict between Israel and Hamas escalated. Oil prices surged, stock markets faltered, and the Israeli currency weakened, setting the tone for a potentially tumultuous period in the financial world.

Oil Prices Surge Amid Middle East Tensions

While Israel is not a major oil producer, the simmering tensions in the oil-rich Middle East rattled investors who had been witnessing a recent decline in oil prices. Factors such as inflation, concerns of a global economic downturn, and a correction to previously surging oil prices had pushed US oil down from approximately \$95 a barrel in late September to just above \$80 last week.

However, on Monday, US oil prices experienced a remarkable 4% increase, reaching above \$86 per barrel. Brent crude, the global benchmark, followed suit, rising nearly 4% to nearly \$88 a barrel.

Israel's Declaration of War and Regional Concerns

The conflict escalated after Israel formally declared war on Hamas in response to the Islamist militant group's deadly surprise assault. This development has resulted in tragic casualties on both sides, with more than 700 people killed in Israel and over 400 Palestinians losing their lives, according to authorities.

Concerns are growing that the conflict could deepen, with potential consequences for energy flow in the region. Susannah Streeter, Head of Money and Markets at Hargreaves Lansdown, noted, "With the Israeli government warning of a long and difficult war, there are concerns that deep and incessant



retaliative strikes on Gaza could potentially bring Iran into the conflict and have an impact on the flow of energy in the region."

Israeli Shekel Weakens, Central Bank's Response

The Israeli shekel faced a notable weakening, reaching 3.92 to the US dollar, its weakest level since 2016. In response, Israel's central bank announced plans to sell up to \$30 billion worth of foreign currencies. This measure aims to stabilize the currency and ensure the proper functioning of markets. An additional \$15 billion of support is also available, pending the situation's development.

Global Stocks and Economic Concerns

In global equity markets, the conflict's repercussions were felt. US stocks, which had seen a surge on Friday due to a robust American job market report, displayed mixed performance. The Dow initially opened lower but later gained by 39 points or 0.1%. The S&P 500 registered a marginal increase of 0.05%, while the Nasdaq Composite saw a slight decline of 0.3%.

European stocks also faced a dip at

the opening of the trading session. France's CAC 40 index fell by 0.6%, and Germany's DAX index declined by 0.7%. London's FTSE 100 experienced a slight uptick of 0.03%, primarily driven by gains in oil company stocks.

Global Concerns for a Fragile Economic Recovery

The global financial community is wary that the Israel-Hamas conflict could have wider implications. Prolonged tensions in the Middle East have the potential to jeopardize the fragile global economic recovery. Investors fear that the conflict might spill over to affect neighboring regions, particularly Saudi Arabia, adding further uncertainty to an already turbulent market.

The prevailing question for markets remains whether the conflict will remain contained or extend its reach. While initial assumptions suggest a limited impact, the potential for higher volatility and unforeseen consequences looms large. The world watches with a keen eye as the situation unfolds, knowing that global financial stability hangs in the balance.

UFC Reverses Flag Ban:

Dana White Takes a Defiant Stand



IN a noteworthy change of course, the UFC has officially lifted its ban on fighters displaying flags within the octagon, as confirmed by UFC CEO Dana White following the conclusion of Saturday's UFC Fight Night 229 event.

This policy reversal follows a period during which the UFC temporarily suspended the practice of fighters carrying flags, primarily in response to the ongoing Russia-Ukraine conflict. However, the shift in policy became evident when Joe Pyfer proudly unfurled the United States flag following his second-round submission win over Abdul Razak Alhassan at the UFC Apex.

During the post-fight press conference, Dana White shared insights into the situation and explained that the recent Noche UFC event played a pivotal role in his decision to reverse the ban.

"Flags are back," White declared to MMA Junkie and other reporters. "I was on vacation during Mexican Independence Day, and the absence of flags drove me crazy. So I thought, 'Yeah, forget that. We're bringing flags back.' It was driving me crazy."

White acknowledged that, initially, he did not consider the

flag ban a significant issue and did not strongly oppose it. Nevertheless, over time, his discomfort with the situation grew, ultimately leading to this change in policy, allowing fighters to once again represent their countries with pride.

"In a company of this magnitude, numerous decisions are made, and you can't oversee every detail," White explained. "Sometimes actions are taken with the best intentions. Everyone here knows my stance on many things: essentially, 'I don't care' is the answer to most issues."

Expressing his frustration with what he perceives as excessive sensitivity, White revealed how his perspective shifted. "People are too delicate, too sensitive about everything," he said. "When the decision was made to implement this policy, I thought, 'What's the harm if they don't have flags?' But Mexican Independence Day was a turning point, and I decided, 'That's enough of the no-flags policy.' Flags are back. If anyone is offended by flags, well, tough luck."

This move by the UFC allows fighters to once again celebrate their heritage and represent their countries with pride, marking a significant change in the promotion's stance on flag displays in the octagon.

Mitch Garver's Grand Slam Propels Texas Rangers to Commanding 2-0 ALDS Lead



IN an electrifying moment during Game 2 of the American League Division Series (ALDS), Mitch Garver, making his postseason debut as the designated hitter for the Texas Rangers, etched his name in the annals of postseason history. With Leody Taveras on third base and Marcus Semien on second, Garver swung the bat with conviction, sending the baseball on a mesmerizing trajectory that culminated in a 419-foot grand slam over Camden Yards' imposing left-field wall. This extraordinary feat not only staked the Rangers to an early 9-2 advantage but also significantly contributed to their eventual 11-8 triumph over the Baltimore Orioles, firmly establishing a 2-0 lead in the series.

Garver's grand slam is a rarity in Rangers history, with only Nelson Cruz's walk-off slam in the 11th inning during Game 2 of the 2011 American League Championship Series (ALCS) against the Detroit Tigers sharing this distinction. It served as a reminder of the colossal impact a single swing can have in the high-stakes realm of playoff baseball. Garver, reflecting on his pivotal moment, remarked, "These playoff games, one swing can change it," underscoring the pivotal role his grand slam played in boosting the team's morale and clinching the crucial win.

The grand slam's significance was amplified by the unique characteristics of Camden Yards. This season, only 33 home runs cleared the left-field wall at this ballpark, the fewest among all MLB stadiums. Garver's blast, ranking as the fifth hardest-hit home run of his season, would have been a home run in every MLB park, marking it as his eighth no-doubter this season. Semien humorously quipped, "Left field here is so deep, but when he hit it, I knew it was gone. That just tells you how hard he hit it."

The Rangers had encountered challenges in the third-hole batting position in recent games, with a mere .143 average from their three-hole hitters in the previous three postseason games. However, Garver, with a regular-season slash line of

.270/.370/.500 across 87 games, rose to the occasion in his postseason debut. His pivotal hit equaled the Rangers' post-season single-game record of five RBIs, previously achieved by Cruz and Michael Young.

Garver's grand slam represented a turning point in the game. Initially, the Orioles had seized a 2-0 lead in the first inning, but the Rangers responded with an explosive five-run second inning, setting the stage for Garver's heroics in the third.

Garver attributed the team's offensive prowess to disciplined plate discipline, avoiding chasing pitches, and a versatile hitting approach. This adaptation in their batting strategy proved pivotal, contrasting with their swing-heavy performance in the previous game.

In conclusion, the Rangers' decisive 11-8 victory, propelled by Mitch Garver's historic grand slam, has them on the brink of an ALDS triumph. As the series unfolds, the Rangers' adaptability and clutch performances continue to be key factors in their post-season success.

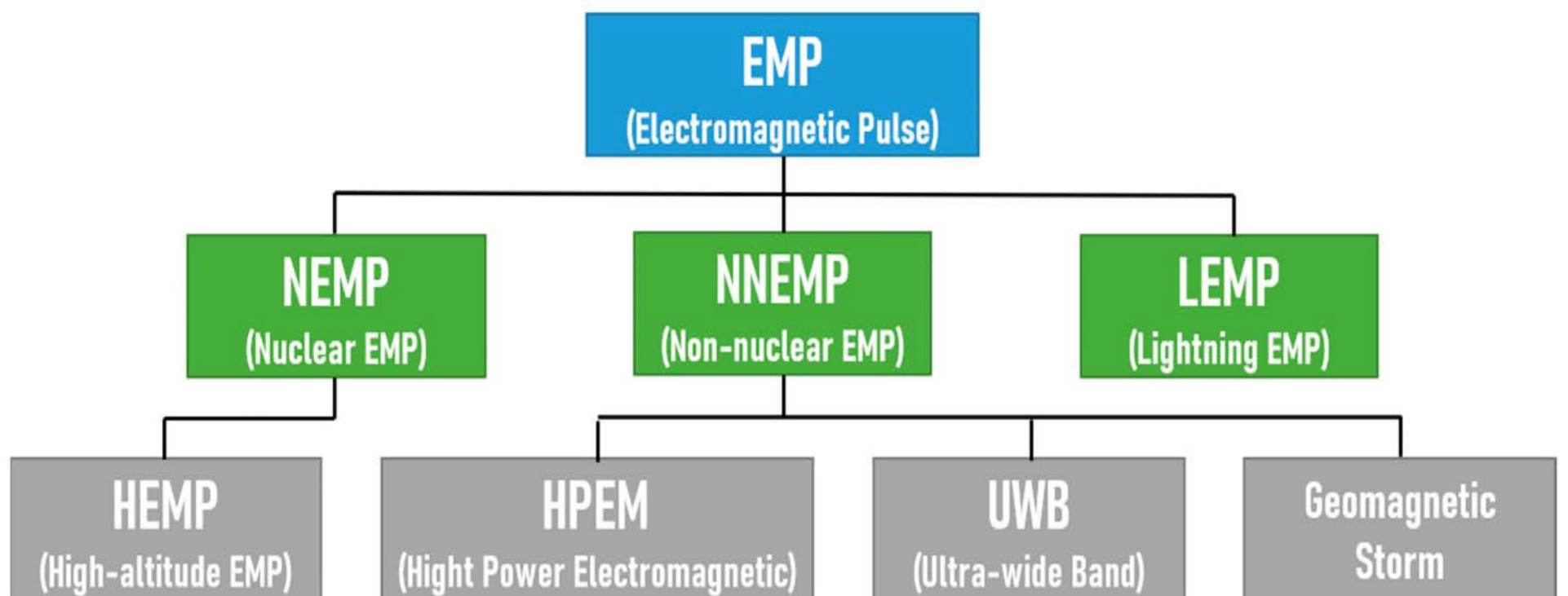

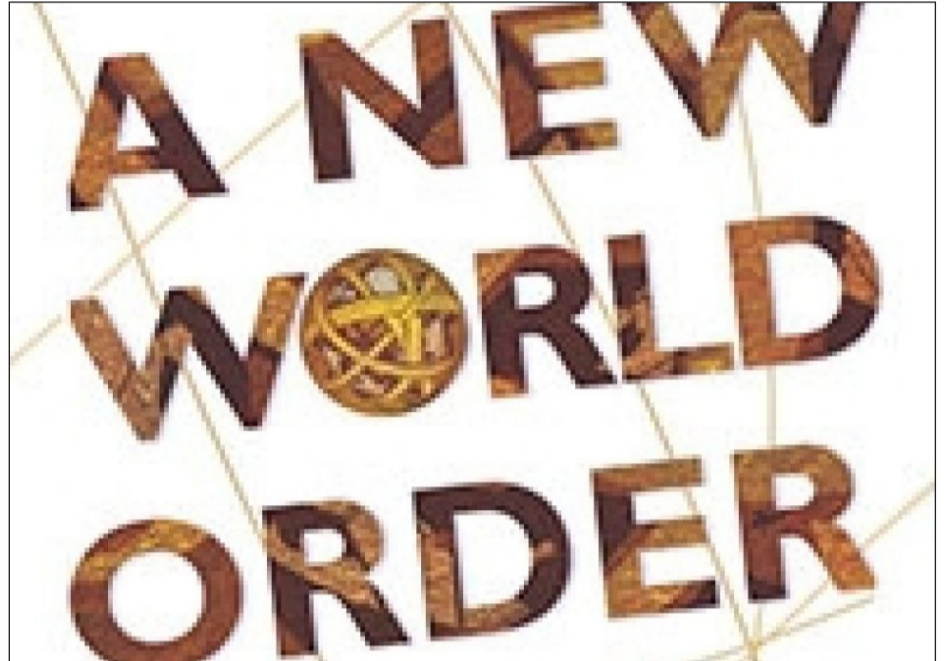
